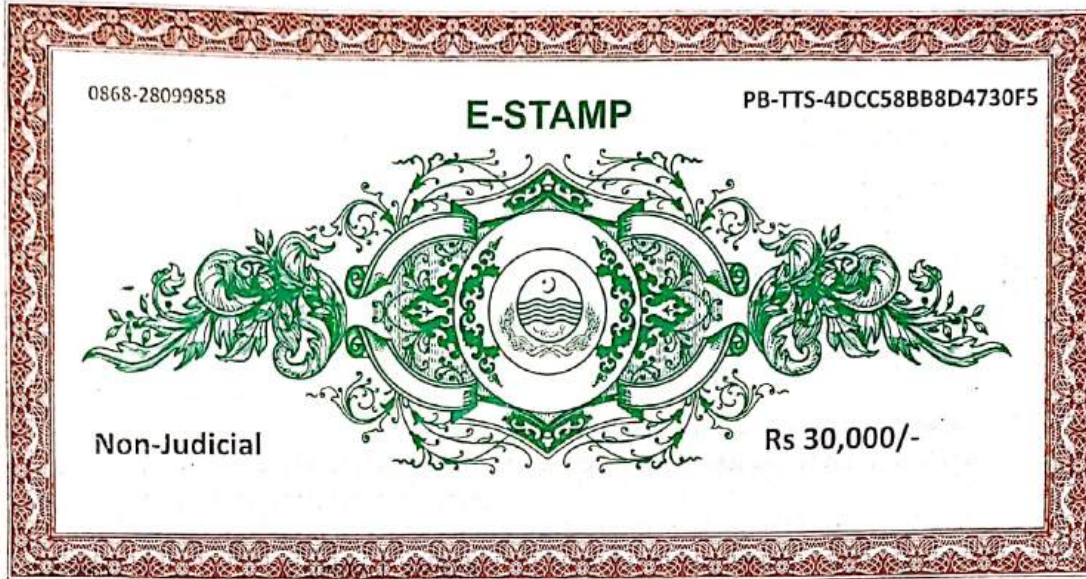



3. The contractor will have to complete the work within the stipulated period according to specification as mentioned in the acceptance letter and Contract Agreement to the entire satisfaction of the engineer in-charge.
4. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy defects therein in conformity and in all respects with the provisions of the Contractor.
5. That if the contractor fails to comply with any of the conditions of the contract, he will be held liable for the consequences thereof which shall be either in the form of liquidated damages or allotment of work at his risk and cost or both. The damages so incurred shall be recovered from the contractor, either from his security money or his running / outstanding bills. Further, if any information / document submitted by contractor / firm, founds false, fabricated, materially incorrect at any stage, he/firm will be liable for blacklisting.

The Employer hereby covenants to pay the Contractor, in consideration of the execution and completion of the Works as per provisions of the Contract, the Contract price or such other sum as may become payable under the provision of the Contract at the times and in the manner prescribed by the Contract.
