

Further, if any information / document submitted by contractor / firm, founds false, fabricated, materially incorrect at any stage, he/firm will be liable for blacklisting.

The Employer hereby covenants to pay the Contractor, in consideration of the execution and completion of the Works as per provisions of the Contract, the Contract price or such other sum as may become payable under the provision of the Contract at the times and in the manner prescribed by the Contract.
